#### **NOTICE OF RACE**

**PUERTO PORTALS MEDITERRANEAN CUP WILL BE CELEBRATED IN PUERTO PORTALS SEA WATERS FROM 14<sup>th</sup> APRIL TO 16<sup>th</sup> APRIL 2017 THE ORGANISING AUTHORITY IS CLUB DE REGATAS PUERTO PORTALS, INTERNATIONAL DRAGON ASSOCIATION, THE SPANISH DRAGON ASSOCIATION AND BALEARIC SAILING FEDERATION.**

#### **1. ORGANIZATION**

Puerto Portals Mediterranean Cup sailing race will be celebrated by Club de Regatas Puerto Portals (CRPP) with the collaboration of The International and Spanish Dragon Associations and The Balearic Sailing Federation.

#### **2. DATES AND MEETING POINT**

The Puerto Portals Mediterranean Cup will take place in sea waters of Puerto Portals from 14<sup>th</sup> April to 16<sup>th</sup> April 2017.

#### **3. RULES**

The Regatta will be governed by:

- a. Rules as defined in The Race Rules of Sailing of the WORLD SAILING 2017-2020.
- b. The requirements of the RFEV to RRV 2017-2020.
- c. The Dragon Race Rules.
- d. Sailing Race Equipment Rules of the WORLD SAILING 2017-2020.
- e. The proceedings contents on the HMS 2014 v2, effective on the 1<sup>st</sup> of July of 2014 or equivalent.
- f. The Addendum Q, 6<sup>th</sup> of June 2014 edition, approved by the WORLD SAILING 2017-2020.
- g. The Sailing Race instructions as well as the Equipment Inspection Instructions.
- h. CIM Rules in force for classic and vintage boats.
- i. International Regulations in force for the Prevention of Collisions at sea.
- j. The modification of the Rules will be published in the Sailing Instructions.



- 3.1. If there is a conflict between the announcement and the instructions, instructions prevail.
- 3.2. In case of discrepancy between the English and Spanish announcement, Spanish announcement prevail.

#### **4. PARTICIPATING BOAT CATEGORY**

- 4.1. Participants must comply the requirements of the WORLD SAILING eligibility code, regulation 19 and pre-inscriptions of the Real Spanish Sailing Federation with such Regulation.
- 4.2. Puerto Portals Mediterranean Cup is open to boats of monotype class: Dragon

#### **5. ELIGIBILITY**

- 5.1. Participants must comply eligibility conditions reflected in regulation 19 and pre inscriptions of the Real Spanish Sailing Federation with such Regulation.

#### **6. PUBLICITY**

- 6.1. Participants may display advertising in accordance with Regulation 20 of the WORLD SAILING, competition rules of the Real Spanish Sailing Federation and pre-inscriptions of the Real Spanish Sailing Federation with such Regulation.
- 6.2. Participants may be required to display the advertising in accordance with regulation 20.3.1 (d) (i) of the WORLD SAILING. It is modified any rule of class that opposes this prevision.
- 6.3. Any advertising will be regulated by the class dragon.
- 6.4. The Organizers reserve the right to require the elimination or substitution of any kind of advertising that, in they opinion, do not comply with moral and ethical rules of general acceptance. (Regulation 20 of the WORLD SAILING).
- 6.5. In case of uncertainty, it is recommended to the Ship-owners apply for approval as soon as possible and always before the registration deadline.

#### **7. PRE-REGISTRATION**

- 7.1. Pre-registrations will be made through the Balearic Sailing Federation website before the 12nd of April 2017

## 9. REGISTRATION

- 9.1. Each Skipper must register and sign the Registry Form in the Organizing Club Offices before 7:00 p.m. of the 14th of April 2017
- 9.2. The following documentation is required for Registration:
- Federated Sailing License of the RFEV or corresponding federation of Participants and Crew.
  - The secretary of the class is the competent authority to be aware of dues. To these effects the National Association will send to the Organizing Committee a list of all those members who at the deadline of registration are up to date in the payment of their dues to the Association.
  - Participants from other Nationalities must present the equivalent and supporting documentation of their National Authority member by the WORLD SAILING of their country and the Civil Liability Insurance document, legally translated into Spanish, for an equivalent amount as Spanish Federative License covers.
  - A photocopy of Identify Document or Passport
- 9.3. Handover of Sailing Instructions: Instructions are delivered as soon as the registration has been formalized in the Race Offices concerning point 9.2 of these Sailing Race Announcement.

## 11. RATINGS

- 11.1 Will apply The Low Score System provided in Appendix A4 of the RRV WORLD SAILING 2017-2020. No score will be excluded.

## 12. PRIZES

- 12.1. Prizes will be awarded to the 1st, 2nd and 3rd classified
- 12.2. Prize will be awarded to the 1st classic vessel better classified



### **13. LIABILITY**

- 13.1. All participants participate in the race at their own risk and responsibility
- 13.2. The organizing entities or any other organization involved with the event will not be held responsible for any physical or personal damages or losses which may affect people or others in sea as in land as a consequence of participation and will be under the entire responsibility of the participants
- 13.3. Please note the fundamental rule 4, decision of racing, part of the RRV, which States:

**“A boat is solely responsible for its decision whether or not to take the start or not to continue in the race.”**

### **14. SAFETY**

- 14.1. The safety of this race is considered of category 4, In accordance with the Special Rules of Racing in the high sea of the WORLD SAILING.
- 14.2. Participants undertake to carry on, under their responsibility, the regulatory documentation of the vessel up to date as well as the proper qualification and equipment for the management of the vessel and the navigation to be made.

### **15. MOORINGS**

- 15.1. Successfully inscription vessels in this Sailing Race will have a free mooring from Thursday, April 13, 2017 at 12:00 p.m. To Monday, April 17, 2017 until 09:00 p.m.

### **16. SUPPORT BOATS**

- 16.1. Support boats from participant vessels must have to request mooring in the Racing Club Office of Puerto Portals before Friday, April 07, 2017.

### **17. RACING COMMUNICATIONS**

- 17.1. The Race Committee will use to communicate during the celebration of the races Channels with frequencies VHF 10, 69 and 16 (emergency)
- 17.2. All participating vessels must be fitted a VHF operating radio receiver with an output power of 25 Watt equipped with at least VHF channels 09, 16 (emergency), 10 and 69

### **18. SOCIAL EVENTS**

- 18.1. All Social Events will be published in the (T.O.A) or in the Instructions of Sailing Race.
